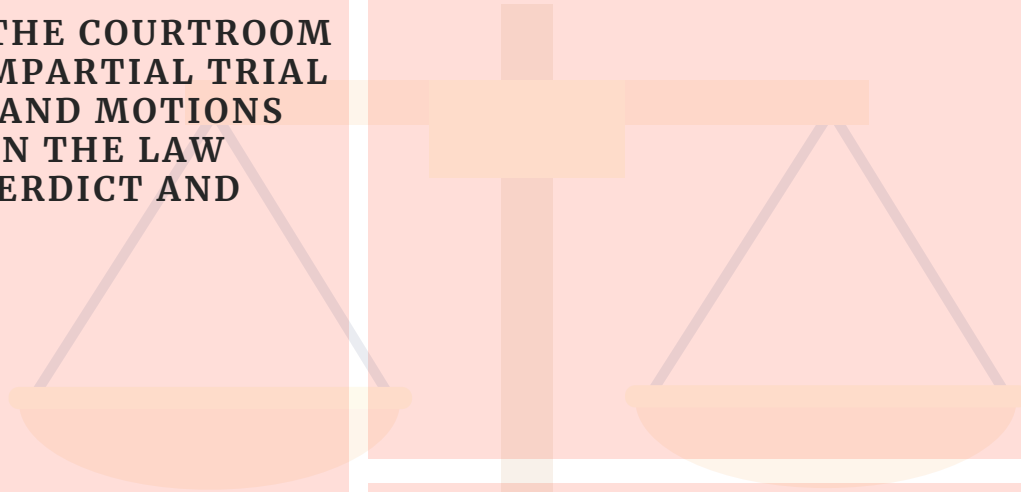

ROLE: PROSECUTOR

RESPONSIBILITIES

- PRESENT THE CASE AGAINST SWEENEY TODD, ARGUING THAT HE IS GUILTY OF THE CRIMES HE IS ACCUSED OF.
- PREPARE AND CALL WITNESSES TO TESTIFY AGAINST SWEENEY TODD.
- INTRODUCE EVIDENCE, SUCH AS DOCUMENTS AND PHYSICAL OBJECTS, TO SUPPORT THE PROSECUTION'S CASE.
- CROSS-EXAMINE THE DEFENSE WITNESSES AND CHALLENGE THEIR CREDIBILITY.
- DELIVER OPENING AND CLOSING STATEMENTS THAT SUMMARIZE THE PROSECUTION'S POSITION AND EVIDENCE.

RESPONSIBILITIES

- REPRESENT SWEENEY TODD AND DEFEND HIM AGAINST THE CHARGES BROUGHT BY THE PROSECUTION.
- PREPARE AND CALL WITNESSES TO TESTIFY IN SUPPORT OF SWEENEY TODD'S DEFENSE.
- CHALLENGE THE PROSECUTION'S EVIDENCE AND WITNESSES THROUGH CROSS-EXAMINATION.
- PRESENT ANY LEGAL DEFENSES OR ARGUMENTS THAT CAN ESTABLISH SWEENEY TODD'S INNOCENCE OR RAISE DOUBTS ABOUT HIS GUILT.
- DELIVER OPENING AND CLOSING STATEMENTS THAT ADVOCATE FOR SWEENEY TODD'S INNOCENCE OR ARGUE FOR A LESSER CHARGE OR PENALTY, IF APPLICABLE.

- RESPOND TO CROSS-EXAMINATION QUESTIONS FROM THE PROSECUTOR AND MAINTAIN CONSISTENCY IN CHARACTER PORTRAYAL.
- ACT IN ACCORDANCE WITH THE ASSIGNED CHARACTER'S BACKGROUND AND BEHAVIOR DURING THE TRIAL.
